On October 29, 2004, the BOT team sent the UFF team via email a counterproposal to the UFF team's October 28<sup>th</sup> Memorandum of Understanding (MOU) addressing the 2004 2005 bonus by legislative mandate. The UFF team submitted a counterproposal to the BOT team's MOU at the November 10, 2004 bargaining session. Later in the evening the teams signed off on an amended version of the document.
- 3. The BOT team presented counterproposals of several articles designated as follows: Article 1 (Recognition), Article 7 (Minutes, Rules, Budgets, and Reports), Article 8 (Appointment and Annual Salary Notification), Article 10 (Employee Performance Evaluations), Article 12 (Non-Reappointment), Article 14 (Promotion), Article 15 (Tenure), Article 18 (Inventions and Works), Article 23 (Salaries), and Article 32 (Definitions). Discussion ensued.
- 4. The UFF team presented counterproposals of several articles designated as follows: Article 3 (UFF Rights), Article 4 (Board Rights), Article 16 (Disciplinary Action and Job Abandonment), Article 17 (Leaves), Article 18 (Intellectual Property), Article 19 (Conflict of Interest/Outside Activity), Article 20 (Grievance Procedure and Arbitration), Article 22 (Sabbaticals and Professional Development Programs), Article 24 (Benefits). Discussion ensued.

The next bargaining session will be held on Monday, November 22, 2004 from 6:00 p.m. – 8:30 p.m. in CAS-192.
