- 3. The BOT and UFF TA'd on the following proposals: Article 1, Recognition; 14, Promotion Procedure; 25, UFF Insurance Deduction; 27, Maintenance of Benefits; 28, Miscellaneous Provisions; and 31, Totality of Agreement.
- 4. The UFF distributed proposal #1, Article 2, Consultation, and UFF Proposal #1, Article 7, Minutes, Regulations, Budgets, and Reports, and they were discussed.
- 5. The UFF stated that they intended to bring Articles 5, 8, and 18 to the table at the next meeting. The BOT agreed that they would bring several proposals for discussion.
- 6. Both parties received a CD audio recording after the meeting.
