- 1. A draft of the 10/13/04 bargaining session minutes was distributed and no changes were made.
- 2. The UFF team presented counterproposals of several articles designated as follows: the Preamble, Article 1 (Recognition), Article 6 (Nondiscrimination), Article 7 (Access to Information), Article 9 (Assignment of Responsibilities), Article 11 (Evaluation File), Article 25 (UFF Insurance Deduction), Article 27 (Maintenance of Benefits), and Article 29 (Severability). Discussion ensued.
- 3. The BOT team distributed counterproposals of several articles designated as follows: Article 1 (Recognition), Article 3 (UFF Privileges), Article 4 (Management Rights), Article 7 (Minutes, Rules, Budgets, and Reports), Article 19 (Conflict of Interest or Commitment/Outside Activity), Article 22 (Sabbaticals and Professional Development Programs), Article 27 (Maintenance of Benefits), and Article 29 (Severability). The BOT team also distributed copies of its Article 5 (Academic Freedom), Article 9 (Assignment of Responsibilities) and Article 18 (Inventions and Works) counterproposals that were previously distributed at prior bargaining sessions. A second proposal of the BOT team's Article 9 Appendix ((Board of Trustees and United Faculty of Florida Exclusive Assignment Dispute Resolution (ADR) Grievance Procedure)) was also distributed. Discussion ensued.
- 4. The UFF distributed two proposed Memorandums of Understanding addressing the 2004 2005 Bonus by Legislative Mandate and 2003 2004 Salary Increases. Discussion ensued.
